

# New York Piano Festival & Competition 2018



## Rules and Regulations

Competition will be held in two rounds. Preliminary round repertoire must be submitted by video links Youtube/Vimeo and emailed to [nypf@newyorkpianofestival.com](mailto:nypf@newyorkpianofestival.com). Preliminary round jury will select fifteen (15) performers in each category to compete in the live round in New York City on June 24 and June 25.

Live rounds will be held at the DiMenna Center for Classical Music (450 West 37<sup>th</sup> Street, New York, NY 10018).

There will be six winners in each category. Twelve winners will perform at the Award Ceremony and Winner's Gala Concert at the Carnegie Hall Weill Recital Hall on June 26th.

**Note:** Competitors invited to the live round will not be allowed to take lessons with NYPF 2018 faculty or participate in the open master classes.

### Eligibility

- New York Piano Festival and Competition is open to pianists of all nationalities.
- Competitors for Category I (Ages 12 to 19) must be born on or before June 24, 2006 and after June 24, 1998.
- Competitors for Category II (Ages 20 to 29) must be born on or before June 24, 1998 and after June 24, 1988.

# Checklist

The following documents must be attached to your application email:

1. **Completed application form**
2. **A copy of passport**, or official birth certificate with English translation, stating applicant's age and nationality.
3. **A copy of certificate of musical study or graduation diplomas**. Notarizing of document is not necessary. English translation of documents required for foreign applicants.
4. **One photo** of participant in JPG format with high resolution (minimum 300 pixels).
5. **Video recordings** of the first round repertoire hosted on Youtube or Vimeo. Selected pieces might be recorded separately on different dates. We advise you to submit high quality video and audio material. Incomplete or poor quality links will be rejected.
6. **Application Fee** – A non-refundable payment in amount of \$150 US Dollars must be paid in full on New York Piano Festival's website via PayPal on or before April 25, 2018. [www.newyorkpianofestival.com](http://www.newyorkpianofestival.com)

## Competition Rules and Regulations

- Preliminary round jury composed of internationally recognized performers and educators (at least 3 members) will independently evaluate submitted video links and vote via 25-point system. In case of a draw, NYPF will add number of participants invited to the live round.
- The performances of contestants for the Live Rounds will be in alphabetical order.
- All works must be performed from memory.
- Performers are not allowed to repeat same compositions from Preliminary round in the Final Live Round.
- All voting decisions of the Competition Jury will be final.
- Competition Jury may stop a performance if the allotted time has expired or for any other appropriate reason.
- Competition Jury may not award all prizes. Prizes will not be shared.

- Selected participants for Category I (ages 12-19), will compete in the Live Round on June 24, 2018.
- Selected participants for Category II (ages 20-29), will compete in the Live Round on June 25, 2018.
- Winners for Category I will be announced by 8:00 p.m. on June 24, 2018.
- Winners for Category II will be announced by 8:00 p.m. on June 25, 2018.
- Competition Jury will select program for each winner to perform on June 26th at the Winner's Gala Concert at the Carnegie Hall.
- Application of the Competition constitutes acceptance by the contestant of all published rules, regulations and procedures.
- All winners will be obligated to perform at the Winner's Concert at the Carnegie Hall on June 26th without compensation.

## Important Dates

New York Piano Festival will present the international Piano Competition from June 24 to June 26, 2018.

**April 25, 2018** – All application materials including Youtube/Vimeo links of the First Round recordings must be emailed to [nypf@newyorkpianofestival.com](mailto:nypf@newyorkpianofestival.com) by 11:59 PM Eastern Time, U.S.

**May 2, 2018** – Acceptance notification for the live rounds will be sent to fifteen performers in each category.

**May 9, 2018** – Deadline for any repertoire changes. All contestants must provide proof of intention for participation in the live round by May 23 (signed letter of participation, along with a copy of airline ticket and hotel reservation if applicable). Failure to provide these materials may result in contestant's disqualification.

**June 24, 2018** – Live Round, Category I (Ages 12 to 19)

**June 25, 2018** – Live Round, Category II (Ages 20 to 29)

**June 26, 2018** – Award Ceremony and Winners' Gala Concert at the Carnegie Hall Weill Recital Hall.

## Logistics

**Foreign Contestants:** Consult your nearest American Embassy or Consulate on advice for visas. If required, New York Piano Festival will send an official letter of invitation.

**Medical Expenses:** Contestants agree to be financially responsible for all medical needs and expenses during their visit as contestants of New York Piano Festival & Competition.

**Housing and Transportation:** All performers invited to the live round will be responsible for their transportation and housing arrangements.

**Practice Facility:** All performers will be provided access to facilities with a baby grand piano for up to 2 hours of practice each day from June 23rd to June 25th. In addition, all participants will have 30 minutes to warm up prior to their live round performance at the DiMenna Center for Classical Music.

**Arrival:** All competitors receive free pass to all NYPF events. Competitors are encouraged but not required to attend New York Piano Festival concerts on June 17, and June 23 at the DiMenna Center for Classical Music.

**Royalty rights for all performances of 20th or 21st Century repertoire are the full and exclusive responsibility of the performer.**
